If it becomes necessary for NNR to utilize a collection agency and/or an attorney to collect any unpaid amount of this invoice, I/we shall be obligated to pay the actual collection agency fees, attorneys' fees and litigation or other expenses, including but not limited to court costs, incurred by NNR, regardless of whether litigation is actually filed.
