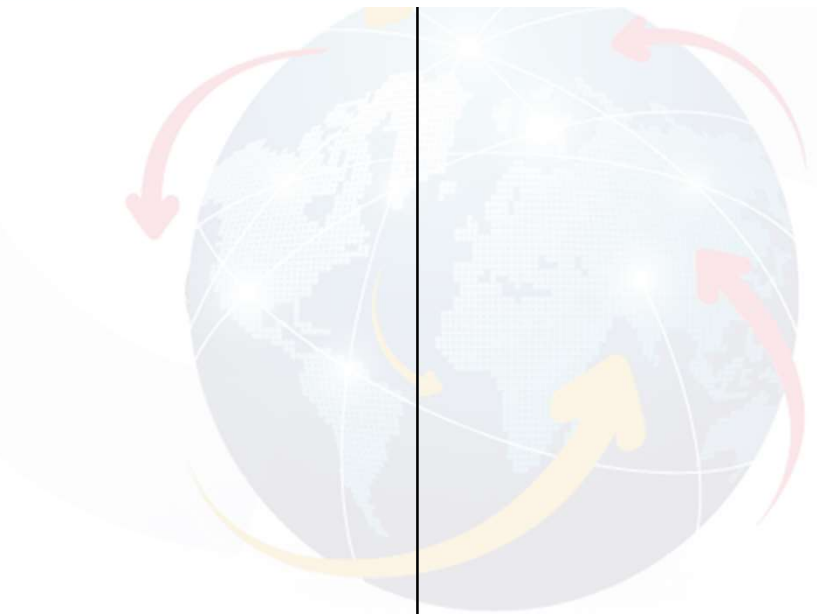

	Chassis Shortage	Due to persistent congestion nationwide, chassis shortages continue to be observed resulting in potential delays for pick up and delivery.														
		<p>Equipment Availability: Due to increased volume at terminals and inland rail facilities, there have been ongoing chassis shortages resulting in pick-up delays and deliveries. Most notably, we are encountering chassis availability issues in the Long Beach/Los Angeles, New York, and Philadelphia terminals, and the Cleveland, Columbus, Louisville, Nashville, St. Louis, Atlanta, Chicago, and Memphis areas.
